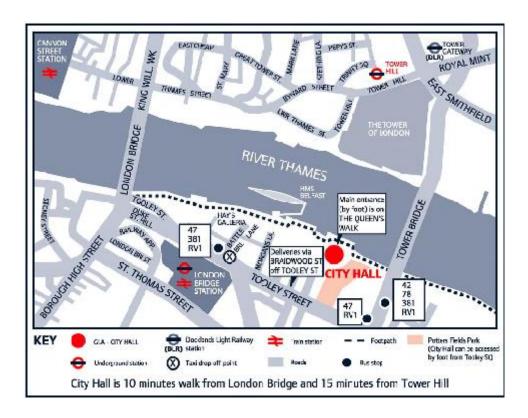
#### **Note for members**
