Section 248 of the Greater London Authority Act 1999 places upon London TravelWatch (as the London Transport Users Committee) a duty to consider - and where it appears to the Committee to be desirable, to make recommendations with respect to - any matter affecting the functions of the Greater London Authority or Transport for London which relate to transport (other than of freight). Section 252A of the same Act (as amended by Schedule 6 of the Railways Act 2005) places a similar duty upon the Committee to keep under review matters affecting the interests of the public in relation to railway passenger and station services provided wholly or partly within the London railway area, and to make representations about them to such persons as it thinks appropriate.

RE: Implementation of Thameslink upgrade programme at London Bridge

I am writing to express the concerns of London TravelWatch about the possibility of reductions in the scope of the works proposed at London Bridge station as part of the Thameslink upgrade programme. This was considered in some details by our board at our recent meeting.

London TravelWatch and its' predecessor bodies have spent a considerable amount of time and energy over several years, considering the various aspects of the Thameslink programme both in terms of closure of parts of the railway and the various planning applications. We supported the proposals on the basis that, although there was some hardship to existing passengers, this was more than outweighed by the additional passenger benefits that the Thameslink upgrade and the rebuilding of London Bridge station.

We would therefore like to seek your assurances that if a reduction in the scope and cost of works at London Bridge is being considered, identified as necessary, that we can be satisfied that:-

- a) the passenger benefits envisaged in the original scheme are preserved or enhanced better facilities at the station, longer trains, more frequent services (such as on the main Thameslink core route between London Bridge and St.Pancras International).
- b) that where there were disadvantages to passengers in the original scheme (such as the reduction in terminating platforms on the lines from Peckham Rye and Forest Hill) that any redesign might be able to accommodate measures to mitigate or reduce the impact of these or that the Department considers with Network Rail and Southern other methods of operation (such as that of 'stepping back' train crew) that would potentially allow the retention of existing frequencies and service patterns.

Along with my board, I would be grateful for clarification of the position in respect of the London Bridge works. I look forward to your reply with interest
