#### Motorcycles in bus lanes

You will know that members have been following the progress of the motorcycles in bus lanes project and have heard from TfL.

Today members discussed the TRL report of the first trial and formally supported the following recommendations. Some have been previously related to your officers.

- i) That London TravelWatch formally requests that TfL undertake additional analysis on the collision data. Firstly for all of the 18 month trial period.
- ii)That London TravelWatch formally requests that TfL undertake additional analysis comparing Transport for London Road Network (TLRN) bus lanes to all other roads in those boroughs with high levels of cycling.
- iii)That TfL be asked to conduct a cost benefit analysis as would be customary for road safety interventions. This would compare the time savings for drivers against the road safety benefits / disbenefits.
- iv)That London TravelWatch reviews this data at its Board meeting in February 2011.

I understood from your officers that the analysis in i) can be available in January which would be ideal for consideration by the Board in early February.
